The meeting was called to order at 9:40 AM by Lisa Furber. All attendees introduced themselves.

1. Approval of the Minutes for the meeting of:

### 3. Discussion of:

DNHRQAC commission staff & members shared brief updates during COVID-19. As of today, 60 - 65% of Delaware deaths related to COVID-19 are residents of long-term care facilities.

#### Norma Jones

- Shared experience as a resident in a Delaware LTC facility.
- Mentioned staff is checking resident's temperature each shift. She expressed that residents should not be woken up during third shift to have temperature check if they are sleeping.
- Brought up about the importance of creative visitation during the State of Emergency Orders.

## Amy Milligan

- Mentioned COVID-19 testing in Wilmington senior housing
- Expressed importance of providing education to vulnerable populations including: individuals with substance abuse, mental health, cognitive or multiple comorbidities.
- Shared that a few Life Center of St Francis participants currently living in LTC facilities have been exposed to COVID positive roommates.
- 240 Life Center community clients are being served at home since day program is closed
- Two COVID positive participants: one recovering at home and one hospitalized with complications

### Lt. Gov Bethany Hall-Long

- Mentioned she has been involved with multiple projects during pandemic
- -Wanted to thank the commission and individuals working to help with vulnerable aging population in Delaware
- PI for Medical Reserve Corp thru position at University of Delaware
- Lt Gov Office is available to answer questions regarding COVID-19 data, etc

## Rep. Kim Williams

- Interacting with constituents and others regarding pandemic
- Connecting with multiple State agencies and legislators to address concerns, figure out solutions, etc
- Participating in Zoom meetings throughout the state
- Involved on conference calls with Re-Opening Schools committee

- Concerns early on in pandemic with: LTC reporting, testing, data, PPE, etc. Representative Williams suggested this group meet in future to see what we learned during pandemic & look at what worked, what did not, etc.
- General Assembly working on going back in session next week

# **Lorraine Phillips**

- Facilitating on-line learning for UD nursing students
- Research shut down but might be opened up at UD in future
- Invited Lisa Furber and Margaret Bailey to guest present during two family nursing classes May 6, 2020 (Family Health & Wellness)
- Philanthropy effort with UD School of Nursing for LTC facility staff (Go Fund Me)

# Hooshang Shanehsaz, RPH

- Shared that we were not prepared in many area's for the pandemic
- Added that resident rights and restrictions imposed due to Emergency Orders has been difficult to navigate for residents living in LTC facilities
- Provided a follow-up about vitamin D or Zinc: Unfortunately, cannot set a policy for unproven treatments or administer medication/therapies such as vitamins to treat residents
- DSAAPD has been working hard with testing residents, infection prevention, etc.
- Four cycles of medication was filled in anticipation of the pandemic

# Kyle Hodges

- Shared that State Council for Persons with Disabilities (SCPD) met virtually yesterday (full council) and invited DHCQ, SHOC and DDDS leadership to provide updates regarding COVID-19. The council plans to submit recommendations to the Governor. Kyle mentioned SCPD is concerned about death rate in licensed facilities, testing, visitations, etc.

### Dr. Michela Coffaro

- Asked about vitamin D or Zinc supplements. The question about vitamins/supplements will be posed to SHOC during 11:00 am call today.

## Christina Kontis, Esquire

- Shared that Medicaid Fraud Control Unit is involved with remote training with HHS & OIG for anticipated fraud schemes.
- 17 staff members rotating in/out of office during pandemic. The remainder are working remotely. Cases are being assigned.
- Referrals are coming in for Medicaid fraud, abuse, neglect and financial exploitation
- Calls often with DHCQ and DMMA about resident concerns.

## Cheryl Heiks

- Bi-weekly calls with State Health Operations Center and LTC providers
- Bi-weekly calls with hospitals and LTC facility Medical Directors (partnered with AMDA to include assisted living facility medical professional, too)
- Personal Protective Equipment (PPE) for LTC facilities
