### Magna Carta Is Subject of New Book, Exhibition

To mark the 800th anniversary of Magna Carta, the great English charter of rights and liberties that received King John's seal in 1215, the Library of Congress in association with Thomson Reuters will publish "Magna Carta: Muse & Mentor," the companion book to the Library's exhibition of the same title that opens Nov. 6.

Edited by Justice Randy J. Holland (Delaware Supreme Court), the book features a foreword by U.S. Chief Justice John G. Roberts Jr. and essays by leading United States and United Kingdom Magna Carta scholars. Law Librarian of Congress David S. Mao provides an insider's overview of the exhibition. Susan Reyburn, a writer-editor in the Library's Publishing Office, recounts the American adventures of the Lincoln Cathedral Magna Carta—the same version appearing this year—which found refuge at the Library during World War II. Other chapters, including contributions from retired Supreme Court Justice Sandra Day O'Connor and retired Lord Chief Justice of England and Wales Lord Igor Judge, examine Magna Carta in history, popular culture, and the shaping of American life and law.

"Magna Carta: Muse & Mentor," the 305-page hardcover book with 100 images, is available for \$69 in the Library of Congress Shop, 10 First St. S.E., Washington, D.C., 20540-4985. The Lincoln Cathedral Magna Carta—one of only four surviving copies of the original issued in 1215—will be on view at the Library of Congress Monday through Saturday, from 8:30 a.m. to 4:30 p.m., in the South Gallery on the second floor of the Thomas Jefferson Building, 10 First St. S.E., Washington, D.C., through Jan. 19, 2015. The exhibition of the great charter and 75 related items is free and open to the public.

The Library's exhibition is made possible by The Federalist Society and 1st Financial Bank USA. "The scholars from the United Kingdom, United States and Canada, define not only the enormous impact on the United States Constitution, but also the relevance of Magna Carta today through books, movies and even the Jay-Z album 'Magna Carta Holy Grail.'"

"Marking the importance of Magna Carta is central to our mission to foster a more transparent, inclusive, ethical and sustainable world," said Patsy Doerr, global head of Corporate Responsibility and Inclusion for Thomson Reuters. "While we begin the celebration of this 800<sup>th</sup> Magna Carta anniversary with the opening of the Library of Congress exhibit and the publication of this volume, *Magna Carta: Muse & Mentor*, we realize this anniversary is also a reminder to all of us that the rule of law is hard fought, and not yet experienced by all.

"We herald the creation of this publication, and the historic documents which used Magna Carta as their basis," Doerr continued.
