ORDER

This 27th day of February 2017, the Court has considered carefully the appellant’s opening brief, the State’s motion to affirm, and the record on appeal and has determined that the judgment below should be affirmed on the basis of and for the reasons assigned by the Superior Court in its well-reasoned Order dated October 20, 2016. The appellant pled guilty in 2012 to a crime he admitted committing in 1993.¹ As a matter of law, his sentence

could only be entered under the Truth in Sentencing Act, which became effective for all crimes committed after June 29, 1990.²
