ADMINISTRATIVE DIRECTIVE NO. 160

This 3rd day of November 2006,

IT APPEARS THAT a number of Administrative Directives are out of date and need to be rescinded, and that the electronic format for Supreme Court administrative directives should be modified to facilitate the accessibility of these directives by clarifying their status.

NOW THEREFORE, IT IS DIRECTED, with the unanimous approval of the members of the Supreme Court pursuant to Delaware Constitution, Art. IV, § 13(1) that:

- (1) The following Administrative Directives are rescinded as no longer appropriate:
 - (A) Administrative Directive 153 (01/29/04). (Established a Permanent Advisory Committee on Administrative Efficiency in the Judicial Branch).
 - (B) Administrative Directive 126 (09/01/00). (Supreme Court personnel matters).
 - (C) Administrative Directive 149 (08/15/03). (Pre-holiday closings).
 - (D) Administrative Directive 110 (02/01/97). (Provided for a subcommittee to oversee technology planning).
 - (E) Administrative Directive 100 (01/10/05). (Required the Superior Court to report to the Chief Justice on the number of times that judges have rotated out of their respective counties).
 - (F) Administrative Directive 91 (07/27/93). (Established fees and costs for the Court of Common Pleas).

- (2) Administrative directives be reorganized into newly created on-line directories to clarify the status of those directives and facilitate the accessibility of the directives. Administrative directives that have current applicability are being retained in the current directory on the website, while directives that are no longer applicable (but useful for reference purposes) are being moved to one of the following archival directories:
 - (A) Rescinded/superseded.
 - (B) Historic relating to a past date or issued only to rescind another directive.
 - (C) Completed action ordered in the directive has been finished.
