Summary Statement:

This position is responsible for processing the Carry Conceal Deadly Weapon (CCDW) Permit Applications within the Prothonotary Department. This is a Casual/Seasonal position not to exceed 29.75 hours per week.

Nature and Scope:

The incumbent should have strong organization, computer and customer service skills. This position requires the employee to communicate clearly and concisely on the phone and in person. Duties include the processing of Carry Conceal Deadly Weapon Permit applications, assisting with special projects, and supporting staff in duties, as necessary.

Failure to do so will result in disqualification. Applicants must meet each of the following qualifications. Failure in any one area will result in a rating of "not qualified."

- 1. Six months experience in document processing which includes reviewing and evaluating records for completeness and conformity with laws, rules, regulations, standards, policies and procedures, resolve deficiencies, interpret information, and track and monitor activities.
- 2. Six months experience in record keeping which includes maintaining records, logs, and filing systems.

- 3. Six months experience in using an automated information system to enter, update, modify, delete, retrieve/inquire and report on data.
- 4. Ability to communicate clearly and effectively.
