On October 13, 2014, NLP filed its Opening Brief on Cross-Appeal (the "NLP Cross-Appeal") and Answering Brief on Appeal (the "NLP Answering Brief").

Defendants Leon Hunter Wilson ("Wilson") and Hunter Company of West Virginia ("HCWV" and together with Wilson, "Hunter Defendants"), by and through their undersigned counsel, hereby join in and incorporate here by reference as if set forth at length, the arguments and legal authorities in the NLP Answering Brief, Section A (regarding declaratory judgment related to Section 4.3 of the

Agreements), and Section B (regarding weight of witness testimony). Hunter Defendants take no position on the NLP Answering Brief, Section C (regarding denial of motion to compel), as the underlying motion to compel was directed to NLP, and as such, Hunter Defendants took no position on the respective motion in the Court of Chancery proceedings. D.I. 86.

Hunter Defendants did not assert a cross-appeal or join NLP's Cross-Appeal regarding Plaintiff's lack of standing, but supported the arguments asserted in NLP's briefs, below, on this issue. D.I. 30-32, 50-51.
